## How to - Track your performance

This functionality may be accessed having firstly selected the appropriate account or portfolio group from the client list on the usual summary page.

Under the Valuation & Account Activity menu item you will now find the Performance option.

Having selected this you will be taken to a page where you need to enter the date range over which you wish to view the account or portfolio performance. In addition to being able to set a date range, you may also select a set time period (1 week, 1 month etc) from the drop down list. If you wish to add another date period to compare the performance against the initial date range, in addition to providing a detailed breakdown for the first selected period, this also shows the return for each selected period within a table called "Performance for selected period". The historic data is limited to nothing earlier than 1<sup>st</sup> January 2018.

The data provided by this facility is as follows:

Account Summary- states the value of the selected account/portfolio at the earliest selected date, along with that at the later date, a note of any capital additions or withdrawals over the selected period, a note of the monetary change, and then a statement of the time weighted total return. The latter is calculated on a daily basis accounting for any capital additions and withdrawals that may have taken place that day.

**Performance Chart**- alongside the Account Summary it is possible to view a performance graph for the account/portfolio for the selected period which shows the percentage movement of it over the selected period.





**Transactions**- this table states the monetary amount for the selected period, of what income has been received, what cash additions and withdrawals have taken place, along with what stock has been transferred in or withdrawn.

**Performance for selected period**- alongside the Transactions is a table stating the total return for the selected period or both this and the second selected period if a user has selected the Comparison option and selected a second time period.

**Top holdings by performance**- this table shows the top 10 contributors to performance for the selected period. This is based on the total return that they have provided over the selected period having also accounted for their percentage weighting. By way of example, had a position's total return for the period been 15% and they had consistently represented 10% of the portfolio over the period, then their contribution for the period would have been circa 1.5%.
